Mr. Block has extensive experience in the design and development of ERP computer software, communication systems, energy systems, education, and entertainment, including pioneering roles in the commercial airline industry, commercial and pay television and cellular telephone operating companies.

INVENTOR AND AUTHOR:

Block is widely known for his pioneering work in communications, information and management technologies. He is the inventor and patent owner of more than 150 issued US and International patents, including patents relating to: Stereo 3D system, Solar energy panels, Smart Utility System, In-Building Communications, Enterprise Management, Information Labeling, Signal Control, Terrestrial and Satellite Distribution Systems, Real-Time Subscriber Billing Systems, Pay-Per-View Television, Parental Control and English Language Education. Block has multiple patent applications pending, including patents relating to emergency communications and interoperability of noncompatible radios.

Block's inventions are licensed worldwide to most of the major consumer electronics manufacturers and have influenced information, communication, entertainment, sports and education, worldwide.

Block is the author of "Whole Business Thinking – Executive Management", published in the U.S. and China. He also created and produced "NO-Togethers", a booklet that identifies medicines and food interactions, a "Truck Driver's Training Manual", and "Abusable Drugs, What Every Parent Should Know". Block was also a contributor to the development of "Metaphonics" an ESL program.

BLOCK'S CURRENT ACTIVITIES

COMMUNICATIONS:

Block is a founder and Chairman of Real-Time Billing, ShipCom, Interoperability Technologies Group and Link Us All.

Real-Time Billing: RTB has 2 granted US patents (5,960,416 and 6,377,938) and several foreign patents related to billing. The RTB technology has been implemented in Telephone Company central office switches in multiple countries.

ShipCom: (www.shipcom.com) Block was a Founder and Chairman of ShipCom, the only FCC Licensed U.S. provider of HF high seas voice and data communication and emergency communications for Emergency Responders. ShipCom has also provided communication services to the US Coast Guard, NOAA, the U.S. Navy and the Canadian Coast Guard.

During the Katrina Hurricane, the US Coast Guard's communication facilities were severely damaged and inoperative. ShipCom took over the Coast Guard watch and provided the communications with

rescue aircraft along the Gulf Coast and with ships at sea for 12-days. In recognition of ShipCom, the US Coast Guard presented Block and his partner Rene Stiegler with a commendation award for helping the USCG save the lives of more than 33,000 people (copy on request).

Interoperability Technology Group (ITG): ITG's Smart Network Platform (SNP) solves the Radio Interoperability problem that has plagued Homeland Security and the US Military. ITG's solution does not require any change in currently deployed radio equipment. The SNP can connect any radio to any radio or other communication system.

Link Us All (LUA): (www.linkusall.com) LUA is a software company that has developed an electronic power of attorney system and an advanced network based presence and cross platform technology for the Internet and telecom networks. The Company has 4 granted U.S. patents and 1 pending patent.

ENERGY:

Block is a Founder and a Managing Partner of LiTricity, a shareholder and Board member of USCL and the Co-Chair of the Advanced Technology Policy Committee of the National Energy Marketers Association.

LiTricity: LiTricity is developing a patented solar energy system based on the concentration of direct and diffuse light onto photovoltaic solar cells. The U.S. patent has been issued and 6 foreign patents are pending (Block is one of 2 inventors). LiTricity solar panels will cost less than current solar panels and will produce more electricity.

USCL: (http://www.usclcorp.com) USCL has developed a low cost real-time energy management and utility metering system for the residential and small business marketplace. The product, EnergyCite, will facilitate conservation of electricity, gas, and water and increase utility revenues and profits through the introduction of value added products and services (VAPS) and the improvement of operating efficiency. Block is one of 3 inventors of the USCL patented technology.

EMS is based on a new generation of real-time management software that addresses the needs of corporate decision-makers, executives, managers, entrepreneurs and business owners, who seek to better understand and improve their company's performance.

Block is a co-founder, Chairman and a principal shareholder of American Entertainment International. He is the former majority shareholder and Chairman of Landmark Entertainment Group and several Television and Pay Television stations.

AEI booked and produced the first western superstar concert attraction to appear in Mainland China, selling out 56,000 tickets for two Mariah Carey concerts in Shanghai. AEI works with national and international concert promoters, television networks and sports events.

HAVEN tells the story of the only 1,000 European refuges allowed into the U.S. during WW-II. Block was a co-founder of the Swan Theater, a star based Repertory Theater in Milwaukee WI.

The US Defense Department, the University of Wisconsin, University of South Alabama and the World Future Society's Futurist magazine published his 1984 paper introducing the concept of a "Worldwide Information Utility". Block business book. "Whole Business Thinking - Executive Management" (WBT) was recently published in the United States and in China. Block has developed a University level course based on WBT.

Block has been a presenter and guest lecturer on many occasions, including lecturing at: the University of California, the University of Wisconsin, the U.S. Air Force Academy, the Massachusetts Institute of Technology (MIT), Beijing University, Tsinghua University, Beijing Academy of Science, Beijing Institute of Technology, Hunan University and Asia University in Taichung, Taiwan.

Block is a Fellow of the ATLAS Transdisciplinary Society and the Society for Design and Process Science (SDPS). Block was also awarded an ATLAS Lifetime Awarded.

REZN8: (www.rezn8.com) Block was the Chairman of REZN8 until the Company was sold to a public company. REZN8 specializes in the development of user interfaces, motion graphics, special effects and "packages" company images. REZN8 clients include Microsoft, Intel, CBS, CNN, ESPN, FOX, Entertainment Tonight and other major corporations, media groups, entertainment companies and development companies. REZN8 has won 9 EMMYS.

Landmark Entertainment Group (LEG): (www.landmarkusa.com) Until June of 2007, Block was the 51% owner and Chairman of the Board of Landmark Entertainment Group (LEG). Landmark's mission was to create new forms of entertainment for global audience. LEG stood at the cutting edge of "experiential design" having created the world's most innovative and successful themed attractions. Landmark created Universal Studios' hit attractions CONAN: THE WARRIER, TERMINATOR II 3D, JURASSIC PARK: THE RIDE, SPIDERMAN 3-D. M&M's ACADEMY for the Mars Corporation, STAR TREK: THE EXPERIENCE for Paramount Parks and The Hilton Hotel in Las Vegas, ALIENS 3-D for Everland, and JAMES BOND 007: LICENSE TO THRILL for all five of the Paramount Parks. Block brought Landmark to China where the company was very successful in developing themed real estate.

Software Development: Block was a founder and first Chairman of UBmatrix, the world leader in XBRL implementation. UBm converted the FDIC to XBRL and works with the SEC to make reporting in XBRL a requirement for all U.S. public companies. Major Central Banks around the world are in the process of implementing XBRL. Block is one of 5 inventors of the UBmatrix patent. The company is now owned by RR Donnelly.

Television Station Ownership and Activities: In the late 1970's and throughout the 1980's Block was the principle owner of broadcast television stations in Los Angeles, Miami and Milwaukee and one of the owners of a broadcast television station in Philadelphia. He was also the principle owner of 4 MMDS television stations in Houston, which he sold to Sprint in 2007.

Block was the founder and first president of SelecTV, a Pay-Tv company that operated Pay-per-view television services in Los Angeles and Milwaukee. The company also obtained 3 of the 11 cable television licenses issued in the United Kingdom to test cable services. Block was also intimately involved in the creation of Canal Plus in France and Cable Plus in the Czech Republic.

Block was the founder and president of Telease, a technology company that developed patented pay-per-view, parental control and conditional access systems which were licensed to cable and satellite distribution systems and consumer product manufacturers worldwide

Advertising Agency Ownership: From the mid 1950's through the mid 1970's Block owned and operated an advertising agency. The agency was ranked 55th largest in the world. Among its clients were The Great Atlantic & Pacific Tea Company (A&P), then the largest retailer in the world with more than \$7 Billion a year in revenues, Kohl's Food Stores and Department Stores, major toy manufacturers and distributors, manufacturers of industrial and consumer products, automobile retailers and associations, Evelyn Wood Reading Dynamics and others.
